5.1- PURPOSE OF THE DATA COLLECTED

AXIS Dental Sàrl may process all or part of the data:

5.2- RIGHT OF ACCESS, RECTIFICATION, AND OPPOSITION

In accordance with the European regulations in force, AXIS Dental Sàrl users have the following rights:

- right of access (article 15 GDPR) and rectification (article 16 GDPR), update, completeness of user data right to block or erase personal user data (article 17 of GDPR), when they are inaccurate, incomplete, ambiguous, outdated, or the collection, use, communication or conservation of which is prohibited
- right to withdraw consent at any time (article 13-2c GDPR)
- right to limit the processing of User data (article 18 GDPR)
- right to oppose the processing of User data (article 21 GDPR)
- right to the portability of the data that the Users will have provided when these data are subject to automated processing based on their consent or on a contract (article 20 GDPR)
- right to define the fate of user data after their death and to choose to whom AXIS Dental Sàrl should communicate (or not) its data to a third party that it has previously designated.

As soon as AXIS Dental Sàrl becomes aware of the death of a User and in the absence of instructions on its part, AXIS Dental Sàrl undertakes to destroy its data, unless their conservation is necessary for probative purposes or to meet a legal obligation.
